- All taught postgraduate applicants who want a deferral must **pay the acceptance deposit of €500** <u>before</u> requesting the deferral and this will be retained for a period of one academic year to preserve the place.
- A student who has commenced Year 1 of a Taught Postgraduate programme that has a deferral option and who wishes to avail of a deferral in Year 1 can apply to the Programme Coordinator for a deferral up to the end of Week 5 of Semester 1.
